REPORTS:

Management:

- Financials have been posted on the website, email was sent out to homeowners with credentials to access the website on Jan. 24, 2025

President:

• Lawn maintenance/landscaping- they are now working on the backyards to remove dead plants and will they will start spraying for weeds as we move into the warmer season

- Gutters- currently there is cleaning and repairs that are underway, there are two units that need a re-direct of water to prevent damage to property. There was damage to a carport while the company was working here, and the gutter company will be repairing this.
- Permits- the recent permits owners signed are in process and we are waiting for an update from the county

Vice President: No updates

Treasurer:

- There was a discrepancy identified on the January financials, this was specific to the water and sewage, and it is being corrected
- There will be savings on trash pick-up costs approximately in the amount of \$1,000 due to 25 units that are unoccupied due to the damage from the storms
- Recycling has been removed from the budget and will save \$400. Not everyone in the community has recycling bins, and for those that do, the pickup has not been consistent and is an ongoing issue.

New business/Open Forum: Homeowners have the opportunity to raise questions/concerns, and we were made aware of some sprinkler issues, HVAC questions which will be addressed during build back, and communication challenges with Cornerstone.
